BEGINNING AT A POINT ON THE NORTHWESTERLY LINE OF SAID LOT 6, SAID POINT LYING NORTH 60°49'55" EAST 24.29 FEET FROM THE MOST WESTERLY CORNER OF SAID LOT 6 (SAID LINE ALSO BEING THE SOUTHEASTERLY END OF METZ PLACE, AS SHOWN ON THE MAP OF SAID TRACT); THENCE SOUTH 11°33'46" EAST 15.07 FEET; THENCE SOUTH 20°14'17" EAST 23.85 FEET TO THE BEGINNING OF A CURVE CONCAVE NORTHEASTERLY HAVING A RADIUS OF 25.89 FEET; THENCE SOUTHERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 28°28'06" AN ARC DISTANCE OF 12.86 FEET TO THE BEGINNING OF A COMPOUND CURVE CONCAVE NORTHEASTERLY HAVING A RADIUS OF 87.90 FEET; THENCE SOUTHEASTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 16°36'49" AN ARC DISTANCE OF 25.49 FEET TO THE BEGINNING OF A COMPOUND CURVE CONCAVE NORTHERLY HAVING A RADIUS OF 79.36 FEET; THENCE EASTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 35°28'40" AN ARC DISTANCE OF 49.14 FEET; THENCE, NON-TANGENT TO SAID CURVE, NORTH 51°37'30" EAST 25.00 FEET; THENCE NORTH 34°03'11" EAST 7.00 FEET, MORE OR LESS, TO THE NORTHERLY LINE OF SAID LOT 6.

THE NORTHERLY LINES OF SAID EASEMENT ARE TO BE SHORTENED SO AS TO TERMINATE NORTHWESTERLY AND NORTHEASTERLY AT THE NORTHERLY LINES OF SAID LOT 6.
